THE 2021 CEDAR COMMISSION WINNERS WERE PROFILED ON THE CHANNEL, AS WERE MUSICIANS WITH OUR ARTISTS COLLECTIVE, LADY MIDNIGHT AND DEEQ ABDI. IN AUGUST OF 2021 WE OPENED THE VENUE DOORS FOR OUR FIRST IN-PERSON PERFORMANCE IN MORE THAN 18 MONTHS. THROUGHOUT THE REMAINDER OF 2021, WE PRESENTED A TOTAL OF 33 LIVE SHOWS. 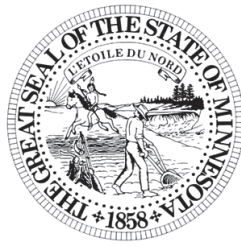
